INGREDIENTS

Water, Thickeners: Erythritol, Cellulose gum and xanthan gum, Cocoa (Theobroma cacao L.) seeds d.e. tit. 40% in polyphenols, Cranberry (Vaccinium macrocarpon Aiton) fruit d.e. tit. 30% in proanthocyanidins, Gojired® (Lycium barbarum L.) fruit d.e. D/E 4:1, Grapeall® (Vitis vinifera L.) fruit, seeds and leaves d.e. tit. with 30% proanthocyanidins and 10% polyphenols, Apple Annurca (Malus domestica Borkh cv Annurca) fruit d.e. D/E 10:1, Pomegranate (Punica granatum L.) fruit d.e. tit. 20% in ellagic acid, Natural flavouring, Preservative: potassium sorbate, Acidifier: citric acid, Sweetener: steviol glycosides from Stevia.

STORAGE METHOD

Store in a cool and dry place. Do not use after the shelf life deadline. Minimum shelf life refers to the product in its intact package and properly stored. Sediments or suspended particles are a natural characteristic of the product.
