INGREDIENTS

Water, Thickener: Erythritol, Rotonda Red Aubergine (*Solanum aethiopicum*) fruit d.e. tit. 1% in amino acids and 1% in micronutrients, Thickeners: Cellulose gum and xanthan gum, Dandelion (*Taraxacum officinale* Weber) root d.e. tit. 2% in inulin, Amaranth (*Amaranthus caudatus L.*) seeds d.e. D/E 4:1, Beta-glucan, Natural flavouring, Preservative: potassium sorbate, Acidifier: citric acid, Policosanols (of which Octacosanol 60%), Sweetener: steviol glycosides from Stevia.

STORAGE METHOD

Store in a cool and dry place. Do not use after the shelf life deadline. Minimum shelf life refers to the product in its intact package and properly stored. Sediments or suspended particles are a natural characteristic of the product.
