## INGREDIENTS

Water, Thickeners: Erythritol, Cellulose gum and xanthan gum, Natural peach flavor, Sweet clover (*Melilotus officinalis* Pallas) flowering herb d.e. tit. 15% in coumarin, Polyporus (*Polyporus umbellatus* Pers. Fr. Fr.) mushroom d.e. tit. 30% in polysaccharides, Dandelion (*Taraxacum officinale* Weber.) root d.e. D/E 4:1, Pilosella (*Heracium pilosella* L.) grass d.e. D/E 4:1, Pineapple (*Ananas comosus* L. Merr.) d.e. 250 GDU/g, Preservative: potassium sorbate, Birch (*Betulla pendula* Roth.) seeds d.e. D/E 4:1, Acidifier: citric acid, Sweetener: steviol glycosides from Stevia.

## STORAGE METHOD

Store in a cool dry place. Do not use after the deadline for storage. The minimum storage term refers to the product in an intact and correctly stored package. Any sediment or suspended particles are a natural characteristic of the product.
